MOSES KOTANE LOCAL MUNICIPALITY ACHIEVES UNQUALIFIED AUDIT OPINION FOR 2021/2022 FINANCIAL YEAR



It is against this background, that MKLM presents that the Auditor-General South Africa (AGSA) conducts regular discretionary audits or assessment of national, provincial government departments, as well as municipalities on an annual basis. In addition, AGSA publishes audit with regard to outcomes of audit in accordance with the Public Audit Act, 25 of 2005.

Therefore, Moses Kotane Local Municipality has received an Unqualified Audit opinion for the 2021/2022 financial year from the Auditor-General of South Africa (AGSA) signed and delivered on the 30th November 2022.

As Moses Kotane Local Municipality, we can attest that the previous five year's Audit History was not easy but a mammoth committed mission as we aimed to improve audit outcome as follow:

- In the financial year 2017/2018, the municipality obtained *Disclaimer Audit Opinion.*
- 2018/2019, the municipality also obtained *Disclaimer* Audit Opinion.
- 2019/2020, the municipality improved to the **Qualified** audit opinion.
- 2020/2021, the municipality remained stagnant as it obtained another **Qualified audit opinion** which saw improvement in reduction of Audit findings from 11 Audit paragraphs to only Two paragraphs.
- Now with stringent internal control and compliance issues in place, in 2021/2022, the municipality significantly improved and obtained UNQUALIFIED AUDIT OPINION WITH FINDINGS.

Moses Kotane Local Municipality vowed its commitment in improving its Audit outcomes as follow:

- * Greater innovation strategy was introduced by the municipality, which is why it started an *interim annual financial statement audit*. To do this, the municipality initiated contacting AGSA before the final audit to come identify any potential grey areas, followed by the municipal willingness to address those areas in preparation for the final Audit. This improved the efficiency of final Annual financial statement to be submitted.
- * The municipality also made improvements to internal controls, such as increased financial accountability for using public funds economically and efficiently. This led the municipality to correctly retain all financial records, align with all necessary compliance requirements, mitigate risks, etc.
- * The municipality developed, implemented the post audit action plan (PAAP).
- * The municipality have demonstrated Appétit to confront the issue of Unauthorized, Irregular, Fruitless, and Wasteful (UIFW) expenditure.
- * However, it must be put on record that some of the UIFW is not a recent activities but dates back from 2012/2013 financial years and truthfully reduction of such effects cannot not be achieved overnight.

In Conclusion

As the Mayor of Moses Kotane Local Municipality Cllr Nketu Nkotswe, I would like to applaud the management, staff members for their dedication, commitment and the Council for active leadership, oversight role played from web of Disclaimers to Unqualified audit opinion. This shows the capability of Moses Kotane Local Municipality to now going towards achieving Clean Audit (unqualified Audit opinion with findings). Indeed, as municipality through all these dedications, we have a story to tell towards transforming this municipality into greater heights. Let us all continue to take note, implements all AGSA recommendations in enabling accountability and thus promoting sound financial governance practices needed in South Africa.

- The Council of Moses Kotane Local Municipality has during its sitting on the 04th October 2022 as per resolution item 43/09/2022 saw it befitting towards service delivery to re-appoint the Accounting Officer namely Mr Mokopane Letsoalo, who will in capacity is enhancing proper financial management of the municipality is in line with prescribed legislations, that internal controls are put in place and most important ensure that our planned Integrated development plan is fully resourced, budgeted towards achieving service delivery to the people.
- In addition, the Council appointed Mr. Frans Dirane Radiokana as Head of Department Corporate Support Services in accordance with resolution taken on Item 37/08/2022. It is important to remember that the Corporate Director function is also of utmost significance because efficient human resource management, sound labour relations in place, and the recruitment of a capacitated workforce towards achieving institutional performance are other ways to deliver services.
- Mr. Given Tshitereke Masheleni was later appointed to be Head of Department for Planning and Development on the Council held on October 28, 2022, in accordance with decision item 38/08/2022. This senior management is also critical in efficient rural and urban planning developments. Congratulations to all of the newly appointed senior

particularly local government, and who are dedicated to bringing this municipality to new heights. Not forgetting, various hard working heads of departments/ senior managers who held the forts on the absence of the accounting officer, as acting in various important senior management positions.

As Administration, we can attest that, It has been a gruesome journey to extricate ourselves from the bondage of Disclaimers to Qualified opinions and to **Unqualified opinion in the 2021/2022 Financial year.** This is a big Achievements which is remarkable and a collective hardworking effort.

Despite the achievements that prevails, there are also Challenges that the administration still encounter which are:

- Water supply interruptions Lack of Water
- Water quality
- Low revenue collection which limits quality services to be rendered.
- Slow planned municipal development due to poor and aged infrastructure.
- High youth unemployment
- Social issues such as Crime, Gender Based Violence & Femicides.
- Slow pace in dealing with UIFW (unauthorized, Irregular, Fruitless &wasteful) expenditure. However, the Municipality has managed to drastically reduce the number of Audit findings over the last 3 years. We need to put an extra effort to address the outstanding matters of emphasis raised by Auditor General in order to obtain a Clean Audit. We are equally pleased that the long awaited Unit 7 development has commenced. We also appreciate the generosity of the Provincial Department of Human Settlements in putting up infrastructure in the area for the Municipality. Over 2000 sites will be services as a result of this generosity. That is indeed Intergovernmental Relations at work.
- The SEZ Infrastructure Master plan has also been completed by the DBSA and we should be seeing movement soon.


"Let us all go to the ward level and deliver information, good governance, and accountability to the community," concluded Speaker Mtshali.


